

Continental Retail Promotion: March 2024

Up to \$150 Instant Cash Back

Objective:	To increase sales consideration for Continental tyres through the network.
Promotion Period:	1 st March 2024 – 31 st March 2024
Eligibility:	The offer is available to all consumers who purchase ANY 4 x eligible Continental branded tyres.
Eligible Tyres:	\$50 cash back will be applied at the point of sale when a consumer purchases ANY 4 x 14 - 17" Continental branded tyres (excluding Truck and Commercial Specialty tyres).
	\$100 cash back will be applied at the point of sale when a consumer purchases ANY 4 x 18" - 19" Continental branded tyres (excluding Truck and Commercial Specialty tyres).
	\$150 cash back will be applied at the point of sale when a consumer purchases ANY 4 x 20" or larger Continental branded tyres (excluding Truck and Commercial Specialty tyres).
	All 4 x tyres must be purchased for fitment to a single vehicle at the same time.
	Mixed fitment size on a single invoice is eligible.
	** No fleet, taxi or ridesharing services are eligible
Consumer Purchase Period:	1 st March – 31 st March 2024. Any purchases that fall outside this period will not be accepted.
Methodology:	Consumer: Purchases ANY 4 x eligible Continental tyres from a participating dealer. At the time of purchase, all participating dealers will apply the appropriate (\$50 / \$100 / \$150) discount to the total invoice of the consumer's purchase.
	** All tyres must be purchased from Continental Tyres of Australia

Terms & Conditions - Consumer:

- 1) Promotion commences on 1st March 2024 and concludes on 31st March 2024. The date in which the tyres are purchased online must fall within this period.
- 2) For the month of March 2024 purchase 4 qualifying tyres and receive up to \$150 cash back on your purchase.



- 3) Purchases are eligible on ANY Continental branded tyres (excludes Truck and Commercial Specialty tyres):
 - a. 4 x 14" 17" tyres will receive \$50 off invoice at the point of sale
 - b. 4 x 18" 19" tyres will receive \$100 off invoice at the point of sale
 - c. 4 x 20" or larger tyres will receive \$150 off invoice at the point of sale
- 4) The consumer will receive their cash back off their invoice at the time of purchase, therefore the onus will be on retailer to ensure that the cash back was provided to the consumer according to the terms of the promotion. Continental will direct consumers back to the retailer in the case of any complaints or queries regarding the issue of the cash back.
