

Continental Retail Promotion – CAP October 2025

Up to \$150 Instant Cash Back

Promotion Period:	1 st October to 31 st October 2025
Eligibility:	All Continental passenger, SUV and 4x4 tyres are considered eligible as part of this promotion.
Mechanic:	\$100 cash back will be applied at the point of sale when a consumer purchases 4 x 18" - 19" Continental tyres.
	\$150 cash back will be applied at the point of sale when a consumer purchases 4 x 20" or larger Continental branded tyres.
	All four (4) tyres must be purchased for fitment to a single vehicle at the same time.
	Mixed fitment size on a single invoice is eligible
	No fleet, taxi or ridesharing services are eligible.
Consumer Purchase Period:	1 st October to 31 st October 2025, any purchases that fall outside this period will not be accepted.
Methodology:	Consumer: Purchases any 4 x eligible Continental tyres from a participating dealer. At the time of purchase, all participating dealers will apply the appropriate (\$100 / \$150) discount to the total invoice of the consumer's purchase.
	Dealer: At the time their order takes place, either a \$25.00 incl GST per tyre (18" – 19" tyres) or \$37.50 incl GST per tyre (20" or larger) rebate wi be applied to the invoice.
	** All tyres must be purchased from Continental Tyres of Australia

Terms & Conditions – Consumer:

- 1) The promotion commences at the start of business for the respective retailers on 1st October 2025 and finishes at the close of business hours at the respective participating retailers on 31st October 2025. The date on the qualifying invoice needs to fall within this period.
- 2) For the month of June 2025 purchase 4 x qualifying tyres from a participating dealer and receive up to \$150 cash back on your purchase.
- 3) Purchases are eligible on ALL Continental branded passenger, SUV or 4x4 tyres.
- 4) The following Cash Back value will be applied as per the eligible tyre rim size listed below:
 - a. 4 x 18" 19" tyres will receive \$100 off invoice at the point of sale



- b. 4 x 20" or larger tyres will receive \$150 off invoice at the point of sale
- 5) The consumer will receive their cash back off their invoice at the time of purchase, therefore the onus will be on the dealer to ensure that the cash back was provided to the consumer according to the terms of the promotion. Continental will direct consumers to dealers in the case of any complaints or queries regarding the issue of the cash back.
- 6) Only tyres that are in stock at the time of purchase are eligible as part of this promotion Rainchecks do not apply.
- 7) Fleet and trade purchases are excluded from this promotion.

Terms & Conditions - Dealer:

- 1) The promotion commences at the start of business for the respective retailers on 1st October 2025 and finishes at the close of business hours at the respective participating retailers on 31st October 2025. The date on the qualifying invoice needs to fall within this period.
- 2) All orders must be invoiced on or before 31st October 2025, to qualify for this promotion.
- 3) Purchases are eligible on ALL Continental branded passenger, SUV or 4x4 tyres.
- 4) The cash back is only applicable to tyres purchased from Continental Tyres of Australia by the retailer.
- 5) Four (4) or more Continental tyres will need to be ordered to receive the \$25.00 incl. GST or \$37.50 incl. GST rebate.
- 6) Only tyres that are in stock at the time of purchase are eligible as part of this promotion Rainchecks do not apply.
- 7) Fleet and trade purchases are excluded from this promotion.
- 8) This promotion cannot be used in conjunction with any other Continental discount or offer.
